

TRA / Apple device Prize Draw Competition



Terms and Conditions

1. To enter the 2024 TRA product launch grand prize draw, go to <https://totalrisksa.co.za/productlaunchpromo/> and answer the following question: Name one of the procedure/s or treatments allowed in terms of the Defined Out-Patient (Out of hospital) shortfall procedure list. 2. Only one entry will be accepted per person. Multiple entries from the same person will be disqualified.

5. The draw will take place at TRA at 12h00 on Friday, 1 December 2023. The first drawn entrant will win an Apple iPad.

8. The Promoter reserve the right to vary, postpone, suspend, or cancel the competition and any prizes, or any aspect thereof, without notice at any time, for any reason which we deem necessary.
